#### WHAT YOU NEED TO KNOW ABOUT AB 628 GOING INTO EFFECT JANUARY 1, 2026

California's AB 628 updates habitability standards for rental units by requiring landlords to provide and maintain a working stove and refrigerator. Effective January 1, 2026, these appliances must be included in all new, renewed, or amended leases.

Landlords must also repair or replace any recalled appliances within 30 days of receiving notice of the recall. Tenants' rights to repair-and-deduct or vacate due to untenantable conditions remain unchanged.

Tenants may choose to provide their own refrigerator, but only if this is agreed upon at lease signing and documented in writing.

Exempt units include permanent supportive housing, Single Room Occupancies (SROs), residential hotels, and shared housing with communal kitchens.
